

2 METERS DISTANCE AND EACH FAMILY	
SHOULD OCCUPY DESIGNATED PLACES TOGETHER WHILE ATTENDING WORSHIP/QURBANA. AVOID UNNECESSARY MOVEMENTS	THE NUMBER OF PARISHIONERS ATTENDING OR ALTAR ASSISTANCE FOR ANY PARTICULAR SERVICE SHOULD BE MINIMISED THROUGH THE USE OF ROTA SYSTEM ETC.
SEATING ARRANGED/MARKED TO FOLLOW SOCIAL DISTANCING. FACILITATE FREE MOVEMENT	STRICTLY OCCUPY SEATS AND KEEP WALKWAYS FREE FOR MOVEMENT.
CAREFUL CONSIDERATION SHOULD BE GIVEN TO FILLING SEATS IN ORDER, STARTING FROM THOSE FURTHEST FROM THE ENTRANCE.	OCCUPY SEATS FROM FRONT, FURTHEST FROM THE ENTRANCE (CLOSE TO ALTAR) IN ORDER.

WEAR FACE MASKS AND EXCEPTIONS	HSE DIRECTIVES FOR ANY SPECIAL NEED TO BE FOLLOWED	ADVICE SUGGESTS THAT FACE COVERINGS SHOULD BE USED. DUE REGARD MUST BE GIVEN FOR WHOM FACE COVERINGS MAY BE INADVISABLE. E.G. ASTHMATICS. GOVERNMENT ADVICE SHOULD BE FOLLOWED.

NO KISSING OF HANDS /CROSS (KAIMUTHU)	OFFERINGS CAN BE DROPPED INTO THE OFFERTORY BOX PLACED ON EACH SIDE OF THE AISLES

MINIMUM ALTAR ASSISTANCE	ALTAR ASSISTANCE SHALL BE MINIMISED AND ROTA TO BE FOLOWED.	PHYSICAL DISTANCING, TOUCHING OBJECTS, SURFACES CAN BE MINIMALISED. HYGIENE CONSIDERATIONS SHOULD BE TAKEN INTO ACCOUNT & FOLLOWED WITH CAREFUL SUPERVISION	
NO GATHERINGS IN CHURCH PREMISES BEFORE OR AFTER WORSHIP/SERVICES	AVOID BOTTLENECKS ON DEPARTURE– E.G. INCUMBENT AT DOOR TO SPEAK TO PARISHIONERS.	STRICTLY AVOID CLUSTERS OF PEOPLE.	
CONTACT TRACING / ATTENDANCE	ATTENDANCE SHALL BE MAINTAINED AND RECORDED	FAMILY / INDIVIDUAL'S ATTENDANCE SHOULD ALSO BE CONFIRMED THROUGH PHONE CALL OR TEXT TO PARISH SECRETARY/ DESIGNATED PERSON	
CHILDREN AND INFANTS	SPECIAL CARE AND ASSISTANCE BY PARENTS REQUIRED AT ALL TIMES UNNECESSARY MOVEMNETS & TOUCHING OF SURFACES SHOULD BE AVOIDED	EXTRA CAUTION, TRY NOT TO SHARE ANY TOYS OR PERSONAL BELONGINGS WITH OTHER CHILDREN

- 3. COVER YOUR MOUTH AND NOSE WITH A TISSUE OR SLEEVE WHEN COUGHING OR SNEEZING AND DISCARD USED TISSUE SAFELY
- 4. CAREFUL PERSONAL CONSIDERATIONS AND HYGENE WHILE USING COMMON FACILITIES, TOILETS ETC.
- 5. USE / CARRY TISSUES, HANDTOWELS.
- 6. PERSONAL HYGENE TO BE MAINTAINED AT ALL TIMES, <u>USE HAND SANTIZERS</u> PRUDENTLY.
- 7. ONLY DESIGNATED PERSONS WOULD LEAD SONGS AND RESPONSES, CAUTION WHILE INTERACTING IN CLOSED ENVIRNOMENT.
- 8. AVOID TOUCING COMMON SURFACES, FURNITURE OR EQUIPMENTS.
- ANOUNCEMENTS REGARDING ATTENDANCE FOR WORSHIP /QURBANA SHALL BE COMMUNICATED SOON, TAKING INTO CONSIDERATION THE SAFE CAPACITY, HSE GUIDELINES, & ECCLESIAL GUIDANCE OF THE CHURCH.
 THE SUNDAY SCHOOL AND OTHER SPIRITUAL ORGANIZATIONS SHALL CONTINUE MEETING ONLINE.
 ANY INDIVIDUAL OR FAMILY ATTENDING ANY FORM OF WORSHIP SHOULD BE STRICTLY CONSENT
